



# LIFESTYLE: YOUR BEST MEDICINE - PART I

"Let food be thy medicine," is a famous quote attributed to Hippocrates, the father of medicine. This mantra captures the central role of nutrition and dietary patterns in human health. In other words, if you eat the right diet, it can maintain your health helping you to prevent or reduce the symptoms or even reversing major diseases. There are, of course, many other factors that influence health and longevity.

Let me start with three sad but true stories. A 65-year-old lady comes to see me because of chronic cough and then a touch of blood in the sputum. It

turns out she has developed lung cancer from chronic cigarette smoking. A 52-year-old man collapses with a heart attack while working in the yard and dies. He was quite obese, hypertensive and diabetic. A physician, 70, a chronic alcohol user, suffering from cirrhosis of liver, develops cancer of liver and dies. Could these tragedies have been prevented? The answer is 'yes' because they have a lot to do with an unhealthy lifestyle.

There has been spectacular progress in medicine during the past two decades. We understand the mechanisms of most serious diseases now and there are preventive or treatment measures for all. Yet, people continue to suffer from these diseases, preventable to a large extent. The key factor here is 'healthy lifestyle.' Although, life expectancy has risen in the U.S. in the past, lately there has been a drop – falling to about 78 from the previous high of 80. There are many other countries like Japan, Hong Kong, Switzerland, Spain, Australia, etc., that have much higher life expectancies. So, it's time that we delve deep into this issue and seek some solutions.

Have you heard about 'blue zones,' a designation for places of exceptional longevity? These are areas where people live longer and lead healthier lives than anywhere else on the planet. Blue zone regions are Ikaria, an island in Greece; Okinawa, an island in Japan; the Sardinia in Italy; Loma Linda, a small city in California; and the Nicoya peninsula in Costa Rica. As incredible as it is, the people here generally live much longer ... like into the 90s and many to 100 or better. And they are quite active too in their old age and often do not suffer from many

chronic diseases common in the industrialized world.

What are the special characteristics of those living in blue zone? During a recent vacation to Crete Island, off the coast of Greece, my friend, Dr. Venugopal, a senior cardiologist from West Palm Beach, observed one thing. Crete is close to Ikaria and people here also share much of the same features of inhabitants of Ikaria, especially in the quality and longevity of life. There were many older people walking along the roads and they appeared to be reasonably healthy. He thought, maybe not many own a vehicle, hence they are walking. Hardly there was anybody who is overweight or obese. When asked why they are walking, they said, they prefer not to use their cars for short distance and they like to park their cars at the end of the road and walk the distance to the shopping centers or to their destinations. After dinner, they have a ritual of all family members dancing in their front yard or going for a slow walk. This gentle exercise helps to digest the food and reduces the postprandial rise of blood sugar, and hence beneficial to diabetics. This goes along with the old Indian saying, "Walking 100 steps after supper is good for health." Now, you know why. All these add up.

What is this sudden interest in lifestyle? According to the World Health Organization, 80 percent of heart disease, stroke and Type 2 diabetes and 40 percent of cancer could be prevented, with improvements to diet and lifestyle. "Lifestyle medicine has now become a medical specialty that uses therapeutic lifestyle interventions as a primary modality to treat or prevent chronic conditions including, but not limited to, cardiovascular diseases, Type 2 diabetes, obesity, many gastrointestinal diseases and more. Now, we have an entirely new medical organization called "American College of Lifestyle Medicine" with certified clinicians who are trained to apply evidence-based, wholeperson, prescriptive lifestyle changes to treat and, when used intensively, often reverse such conditions. Fascinating, right? To be continued ...

# **CHILD STATUS PROTECTION AND PREMIUM PROCESSING FOR EB1 PETITIONS**

This month, we would like to share some items of interest to our readers.

United States Citizenship and Immigration Services (USCIS) has announced that it will expand the Premium Processing Program. Effective Jan. 30, 2023, multi-national executives and managers, as well as applicants for National Interest Waivers can use the program, which guarantees review of petitions within 15 days of filing based on payment of an additional \$2,500 filing fee. While it is generally good to get a decision


quickly, those with dependent children close to age 21 should seek expert advice about the implications on Child Status Protection. A child's age for Child Status Protection is generally calculated on the later of either the first of the month when visa numbers are shown as available in the final action chart of the Visa Bulletin, or the date when the I-140 is approved. On that date, the child's age is reduced by the number of days it took USCIS to approve the I-140 Petition. For those chargeable to the India or China quotas, note that the final action date is backed up to Feb. 1, 2022. So, the longer it takes USCIS to process the I-140 petition, the longer the child could remain eligible for child status protection. In some situations, premium processing could adversely affect a child's eligibility to qualify for a Green Card with the parent.

## **More on Premium Processing**

On Jan. 12, USCIS also announced other plans to expand premium processing. In March, USCIS will expand premium processing to certain F-1 students seeking Optional Practical Training (OPT) and F-1 students seeking STEM OPT extensions who have a pending Form I-765, Application for Employment Authorization. In April, USCIS will expand premium processing to F-1 students seeking OPT and F-1 students seeking STEM OPT extensions who are filing an initial Form I-765. Specific dates specific dates for each group will be announced in February.

USCIS states that as they implement the expansion of premium processing in a phased approach, they will continue working toward premium processing availability of Form I-539, Application to Extend/ Change Nonimmigrant Status. USCIS anticipates expanding premium processing for certain student and exchange visitors with pending Form I-539 applications in May and certain student and exchange visitors who are filing initial Form I-539 applications in June. That will be great news for those seeking to change to F-1 student status while in USA on another visa. Currently, many colleges refuse to issue I-20's to students who are seeking a change of status because of the long processing times at USCIS.

# **HYUNDAI OFFERS A VARIED 'ELECTRIFIED' CHOICE**

That Tesla is a leader in electric vehicles is a given. But the frontrunner isn't going to be able to keep the position for long if Hyundai has a say. Or several says (i.e. EVs), for that matter. After all, the Korean carmaker can proudly claim its Ioniq 5 electric SUV as the 2022 World Car of the Year, as well as tout the Kona electric, Tucson PHEV (plug-in hybrid) and regular Santa Fe hybrid. To showcase and experience the diverse lineup, we were recently invited to drive the vehicles in the lush Coconut Grove/Miami neighborhood along the bay and surrounding areas.

The top 5 Southern region markets for electrified vehicles are Miami, Tampa, Orlando while BEV (battery electric vehicles) are again Miami, then Orlando and Tampa. It is no wonder that Hyundai held the 'electrification' media experience in 'The Magic City.' The strategy is to sell one million Hyundai electrified vehicles per year worldwide, revealed Loren Wong, assistant manager of Product Planning at Hyundai Motor N.A. Looking further, the auto manufacturer will produce 11 EVs by 2030. Toward that end, the company has planned a dedicated EV factory in Bryan County, Ga., with production to begin in 2025. And Hyundai is already offering a two-year complimentary charge at any Electrify America

Also present was Andre Carter of Hyundai

division Supernal, an advance air mobility company, that seeks to address congestion and pollution. Its aim is to develop a family of electric air vehicles such as a battery-powered and autonomous Electric Vehicle Take-off & Landing or eVTOL (4-5 passengers) for intra-city passengers by 2028. "We are taking the time to create a safe, light-weight commercial eVTOL that provides our future passengers with the security and comfort they find in their own cars,"

Supernal is aware that the novel electric air vehicle concept cannot be dropped into cities unless a system has been fashioned that works for everyone and effortlessly integrated into current transit networks. Why Miami? Because Mayor Francis Suarez has been receptive to public-private partnerships integrating into his city. Carter terms the air mobility concept as "subway in the sky."

While the Ioniq 5 can go up to 300 miles on a full charge, the Kona electric stretches to 258 miles, thanks to lithium-ion battery packs and electric motors. Fast charging times



just 18 to 55 minutes for 80 percent. With an

Electric Vehicle Take-off & Landing

electric motor and battery pack, the Tucson PHEV travels in electric-mode only for about 33 miles before fuel kicks in. And the Santa Fe hybrid ekes out 37.1 mpg in city, beating EPA estimates of 33. As noted earlier, an array of hip Hyundai EVs is gearing up to hit the market - the midsize Ioniq 6 sedan and the larger Ioniq 7 SUV – are just two examples. It's only a matter of time before the Korean carmaker takes the lead in the EV market, leaving the rest of the rivals far behind!



# WHAT SOPHOMORES (AND THEIR PARENTS) NEED TO KNOW ABOUT COLLEGE ADMISSIONS

Midway through grade 10, students and parents are starting to feel pressure about college admissions. Almost every family who consults with us begins with the same phrase: "I don't know how it works!"

### Let's start with how it does not work.

First, disregard rankings when researching colleges. Rankings are created by companies to make money, and they are often created in concert with the colleges themselves. To say the least, rankings are unreliable. Look up the ranking for the University

of Washington (Seattle) in both the US News National Rankings and its Global Rankings. As of this moment, UDub is ranked No. 55 in the United States but No. 6 in the world!

Second, diminish that unfaltering, ubiquitous yearning for reputation. Instead, focus on how a student and college fit together. There are three factors defining "fit": the structure and flexibility of the academics and curricula (not the perceived "quality"); the on-campus culture; and the off-campus opportunities for learning (internships) and inspiration (recharging the body and soul).

Third, when it comes to high-level coursework like AP or IB HL, more is not better. Students should challenge themselves in areas that are relevant (either a true interest area or something to investigate) and "back off" on topics that are less interesting. This strategy tends toward a higher GPA, more time for extracurricular activities (and sleep), and a

better explanation of "who I am" to the admissions offices. Colleges are not picking based upon curriculum; they are selecting human beings. Using the rule of "better, not more" when it comes to academics, always embrace the exception: talk to your high school counselors and get their advice about coursework.

BTW – when picking between classes, remember that most classes have their syllabi posted online. Look before you leap!

Fourth, when deciding what to do beyond academics, know that admissions is not about checking boxes. Don't do things just to do things. Don't expect expensive summer programs to pave your way into top colleges. Don't count on hours and hours of community service to make a huge difference to an admissions office. Things matter to them only if they matter to you.

Fifth, get your highest grades and test scores, but do not think that being first or second in your class guarantees good admissions results. Being top of your high school does not make you top of the world.

#### So how does admissions work?

Admissions is not a linear process. A public university beyond your home state will evaluate you differently than will a public university within your state. Public universities and private universities have different purposes and admissions criteria. While public universities tend to focus more on objective materials like grades and test scores, private universities often use a more holistic, multi-faceted admissions matrix in deciding who gets in and who gets rejected.

In fact, for America's top colleges, great grades and scores are only the beginning of their inquiry. How a student may contribute to a campus community is much more important than their SAT score. That's why private schools emphasize extracurricular activities and also why they ask for so many essays, plus recommendation letters, perhaps also an interview. It's not just about whether you are qualified. It's about whether you are valuable to them, and "them" means the entire student body.

As for the SAT or ACT: Take the test (and prepare for it as well as you can). Everything on an application is an opportunity to impress a college. Take your shot! If you cannot achieve the score you want, consider applying "test optional" without reporting your best score. But don't avoid the SAT just because you think you're "not a good test taker." That's just fear (or laziness).

It is common for 10th graders and their parents to wonder about so many college-related things. "I know I should be doing something more, but I don't know what to do!" Yes, the process can be overwhelming, but a quality, experienced admissions professional can help. That includes your high school counselors, not just outside consultants like UCA. Get involved early, and things will be easier, less stressful, and more successful when the time comes.

Finally, manage your expectations of what you can actually accomplish. Achieving America's top universities is as challenging as making an Olympic team. Still, we don't believe in teaching young people to quit just because things are hard. Instead, let's reach for those "reach schools" that you covet, but let's be sure to find great options at all levels. Let's do this!



# TAX PLANNING

# **GETTING READY FOR THE 2023 TAX FILING SEASON**

Jan. 23 marked the start of the 2023 tax season and the date the IRS began accepting and processing 2022 tax year returns. More than 168 million individual tax returns are expected to be filed, with the vast majority coming before the April 18 tax deadline. Of note, this year is that there are three extra days to file this year due to the calendar. While filing your 2022 tax return promises to be just as

complicated as always, there are steps that taxpayers can take right now to ensure their tax filing experience goes smoothly. Let's look at what's new for 2022 and some key

items taxpayers should consider before filing.

#### **What's New**

No above-the-line charitable deductions. During Covid-19, taxpayers could take up to a \$600 charitable donation tax deduction on their tax returns. However, in 2022, those who take a standard deduction may not take an above-the-line deduction for charitable donations.

More people may be eligible for the Premium Tax Credit. For the tax year 2022, taxpayers may still qualify for temporarily expanded eligibility for the premium tax credit.

Some tax credits return to 2019 levels. This means that affected taxpayers will likely receive a significantly smaller refund compared with the previous tax year. Changes include amounts for the Child Tax Credit (CTC), Earned Income Tax Credit (EITC), and Child and Dependent Care Credit.

- Those who received \$3,600 per dependent in 2021 for the CTC will, if eligible, get \$2,000 for the 2022 tax year.
- For the EITC, eligible taxpayers with no children who received roughly \$1,500 in 2021 will now get \$500 in 2022.
- The Child and Dependent Care Credit return to a maximum of \$2,100 in 2022 instead of \$8,000 in 2021.

Refunds may be smaller in 2023. Taxpayers will not receive an additional stimulus payment with a 2023 tax refund because there were no Economic Impact Payments for 2022. In addition, taxpayers who do not itemize and take the standard deduction won't be able to deduct their charitable contributions.

## **Gather 2022 Tax Documents**

The best way to prepare for tax filing is to gather important tax documents - either electronic or paper - and keep them in one place. These documents include but are not limited to: Forms W-2 from employers, Forms 1099 from banks or other payers, Form 1099-K from third-party payment networks, Form 1099-NEC for nonemployee compensation, Form 1099-MISC for miscellaneous income, or Form 1099-INT if you were paid interest, as well as records documenting all digital asset transactions.

Typically, year-end forms arrive by mail or are available online mid-to-late January. Taxpayers should carefully review each income statement for accuracy and contact the issuer to correct information that needs to be updated.

Ensuring their tax records are complete before filing helps taxpayers avoid errors that lead to processing delays. When they have all their documentation, taxpayers can file an accurate return and avoid processing or refund delays or IRS letters.

### **Avoid Refund Delays and Understand Refund Timing**

Many different factors can affect the timing of a refund after the IRS receives a return. Although the IRS generally issues most refunds in less than 21 days, taxpayers should not rely on receiving a 2022 federal tax refund by a certain date. As such, making major purchases or paying bills is not wise until the refund is received. Some returns may require additional review and may take longer to process if IRS systems detect a possible error, the return is missing information, or there is suspected identity theft or fraud.

Also, taxpayers should be aware that the IRS cannot issue refunds for people claiming the EITC or Additional Child Tax Credit (ACTC) before mid-February. The law requires the IRS to hold the entire refund – not just the portion associated with EITC or ACTC.
